Our officers undertake a mandatory training course covering all aspects of Basic Security Awareness, following the agreed subjects set out in the SITO Training Manual. Other items covered are Powers of Arrest, Health and Safety, Body Language and Report Writing.

In addition, 1st Class Protection also provide our officers with **First Aid**, **Krav Maga** (selfdefense), **Anti-Terror Training (ATT)**, and we comply with all SIA requirements, including British Standards, the understanding of UK law, uniforms, and other SIA Regulations. All officers are continually assessed and training is conducted on a continual basis. Typical roles and responsibilities include but are not limited to:

- Provide a clear visual deterrent for those seeking to do harm, vandalise or trespass.
- Control access and challenge anyone deemed suspicious.
- Remain vigilant and aware of potential security threats.
- Report incidents or suspicious activity.
- Perform regular, random perimeter patrols with check points.
- Run invacuation/evacuation and fire drills.
- Scan post/packages.
- Carry our searches: body or bag, where required.


